A RESOLUTION PROPOSING AN AMENDMENT TO THE CONSTITUTION OF THE UNDERGRADUATE STUDENT BODY REGARDING ENDORSEMENTS

Resolved by the Student Senate of the University of Notre Dame du Lac,

That the Constitution of the Undergraduate Student Body, pursuant to Section I (5) of the same, is hereby amended as follows:

I. Whereas Subclause XVII (4) (g) as it currently stands follows:

- (1) Endorsements shall include public, formal, or organized communication or appearances indicating support for a candidate or ticket.
- (2) Candidates/tickets may solicit and campaign on endorsements from student groups and from individual students.
- (3) No Student Union organization enumerated in this Constitution may endorse a candidate for a student office.
- (4) Individuals holding the following offices enumerated in this Constitution may not endorse any candidate or ticket:
 - (a) Student Body President.
 - (b) Student Body Vice-President.
 - (c) Student Body President-elect.
 - (d) Student Body Vice-President-elect.
 - (e) Chief of Staff.
 - (f) Members of the Election Committee.
 - (g) Student Union Board Executive Director.
 - (h) Student Union Treasurer.
 - (i) Class Council Officers.
 - (i) Off-Campus Council Officers.
 - (k) Hall Presidents Council Co-Chairs.
 - (1) Hall Presidents and Vice-Presidents.
 - (m) Club Coordination Council President.
 - (n) Hall Senators.
 - (o) Off-Campus Senator.
- (5) No individual currently holding an office enumerated in this Constitution may endorse a candidate for that same office.
- (6) Candidates may not communicate an endorsement such that it can be construed to represent that of a Residence Hall, Student Union Organization, University department, office, or official.
- (7) No student group may use funds of any type (allocated or unallocated) to support a candidate for a student office.



II. Subclause XVII (4) (g) (4) is hereby amended to read as follows:

- (4) Individuals holding the following offices enumerated in this Constitution may not endorse any candidate or ticket:
 - (a) Student Body President.
 - (b) Student Body Vice-President.
 - (c) Chief of Staff.
 - (d) Members of Executive Cabinet.
 - (e) Student Body President-Elect.
 - (f) Student Body Vice-President-Elect.
 - (g) Members of the Election Committee.
 - (h) Student Union Board Executive Director.
 - (i) Student Union Treasurer.
 - (j) Class Council Officers.
 - (k) Off-Campus Council Officers.
 - (1) Hall Presidents Council Co-Chairs.
 - (m) Hall Presidents and Vice-Presidents.
 - (n) Club Coordination Council President.
 - (o) Hall Senators.
 - (p) Off-Campus Senator.
