[COVID-19 Disciplinary Proceedings to Respect the Principles of Due Process](#)

1. Thomas Davis: I will yield ten minutes to the petitioner Mike Dugan to be taken back at any time.
2. Mike Dugan reads the purpose of the petition.
3. Questions:
 - a) Mike Dugan: At this time I will now open the floor to questions. I cannot amend this because I am not a Senator, but there is a revision indicated in the google doc if someone would like to motion for a friendly amendment.
 - b) Michael Murakami: I pose the friendly amendment. I also would like to commend you for this; it is really well written.
 - c) Benjamin Erhardt: I know it was asked at the Town Hall about the possibility of a board that includes students. I am curious as to whether that discussion was had or not? I thought it was a pretty interesting idea to bring up.
 - d) Thomas Davis: I reclaim my time. I did send a followup email to Erin Hoffman Harding. I know she is super busy, especially at this time, but I do hope she will get back to me about it. As J Council President I will be advocating for this. J Council has peer advocates but it is difficult for this to engage in the process as it is written now. I do not

have an answer as of now, but I think it is an idea that will be entertained at the least.

- e) Benjamin Erhardt: Thank you Mike. This is really well written, and we appreciate you advocating for students. How would you see this playing out? Simply the administration getting a hold of this or going to a specific group with preferred solutions?
- f) Mike Dugan: There is a question there as to whether Campus Life Council gets it or the Office of Community Standards after whatever the vote is today. We could work to build up public awareness that this is something the student body is very concerned about. The hope is that the concerns listed in this resolution will call them to action because I find it hard to see a future where they are legally able to keep the hearing the way it is.
- g) Benjamin Erhardt: What would be your response to the position of if a major party is had and the safety threat of COVID-19?
- h) Mike Dugan: Because we have this wonderful thing called contact tracing, people associated with events are more easily tracked down and tested. Even being expeditious, this process of contact tracing, testing, and filing a report will take five days. They will have to send a report to the student, then they will have two days to respond, which can be particularly challenging if they do wind up ill or with school. If the way you turn through cases very quickly is to take away a student defending themselves., then there are greater issues at hand. Each case should still be given a fair share of thought and consideration.

- i) Ricardo Pozas Garza: I do not think you gave a figure for the timeline of the petition and for how many signatures were received.
- j) Mike Dugan: There are just between 800 and 850 signatures provided since the 27th of January.
- k) Ricardo Pozas Garza: This petition is collecting a very substantial number of signatures in the short timespan of a week, especially given that there has been just one full day of class. I do think we should vote for this; it is clearly weighing on the hearts of the students.
- l) Madison Nemeth: Recommendation to end questioning and move into debate.
- m) Michael Murakami: Motion to end questioning and move into debate.

- n) Renee Pierson: I think the sooner we pass this the better. OCS violations are going to start rolling in, and I think this is really good.
