**AN ORDER TO AMEND THE CONSTITUTION OF THE UNDERGRADUATE
STUDENT BODY TO REFLECT CHANGES TO THE CAMPUS LIFE COUNCIL**

Whereas, on February 25, 2021, the Campus Life Council voted to update its bylaws, including the student voting membership of the Campus Life Council;

Whereas, a representative from Diversity Council, PrismND, the Class Councils, the Off-Campus Council, and an appointee of the Student Body President were made voting members of the Campus Life Council;

Whereas, the Judicial Council President, SUB Executive Director, and Chief of Staff were made non-voting members of the Campus Life Council;

Whereas, the updated bylaws of the Campus Life Council state that the Student Senate shall elect one Senator from a men's dorm and one Senator from a women's dorm to serve as voting members of the Campus Life Council;

Whereas, the Constitution of the Undergraduate Student Body should be updated to reflect the present bylaws of the Campus Life Council; therefore be it

Ordered by the Student Senate of the University of Notre Dame du Lac,

That the Constitution of the Undergraduate Student Body, pursuant to Section (I)(4) of the same, is hereby amended as follows:

I. Article II Section 1(e) is hereby amended as follows:

(e) The Student Body President shall serve as the chairperson of the Campus Life Council in the capacity outlined in the Bylaws of the Campus Life Council.

(1) The student voting members of the Campus Life Council shall be as follows:


- (A) Student Body President
- (B) One Men's Hall Senator
- (C) One Women's Hall Senator
- (D) One representative of the Hall Presidents Council
- (E) One representative of the Class Councils
- (F) One representative of the Off-Campus Council
- (G) One representative of the Diversity Council
- (H) One representative of PrismND
- (I) One appointee of the Student Body President

(2) The student non-voting members of the Campus Life Council, with speaking privileges, shall be as follows:

- (A) Student Union Board Executive Director
- (B) Judicial Council President
- (C) Chief of Staff

II. Article V Section 3(b)(2) is hereby removed and following causes renumbered accordingly;

III. Article XII Section 3(a)(4) is hereby removed and following causes renumbered accordingly.
