- 7. Mira Moran: How could this conflict with the university requirements [Ways of Knowing]?
- 8. Megan Mikuen: The "design your own major" program is usually in the Arts and Letters program, since that tends to be what the major is housed under. Some classes are still taken outside of the college though. They would get an advisor from that college.
- 9. Creed Leathers: James worked really hard and got all of the ice cream back in the dining halls.

- 26. Derick Williams: Where is the mold?
- 27. Mia Moran: Basically everywhere. When I say mold, I dont think it's always visible, but people who are allergic can tell there is something in the air that makes it harder to breathe.
- 28. Derick Williams: If it's up in the ceilings, students probably can't see it. I was just curious. Thank you
- 29. Sofie Stitt: I know people were getting moved into newer dorms in the past because of that.
