

Timeline Election Amendments

Drafted on 24 January 1999

Article II, Section I #1

*The Student Body President and Vice-President shall be elected by a majority vote of the undergraduate student body prior to the third Thursday in February of each year.*

Article II, Section II #1

*The Student Body President and Vice-President shall be elected by a majority vote of the undergraduate student body prior to the third Thursday in February of each year.*

Article II, Section IV #1

*The Student Union Treasurer shall be nominated prior to the third Thursday in February of each year by the outgoing Student Union Treasurer and approved by the Senate.*

Article III, Section V #1

*Each Senator shall be elected by the undergraduate residents of each hall prior to the last Senate meeting in March of each year. Students who reside off-campus shall elect one undergraduate student prior to the last Senate meeting in March of each year to serve as the Off-Campus Senator.*

Article IV, Section V #6b

*The Selection Committee shall nominate the new SUB Executive Board prior to the first Wednesday in March of each year. The Senate shall review and approve all nominations.*

Article IV, Section V #9a

*The SUB Board Manager shall be nominated by the Selection Committee prior to the first Senate meeting in March of each year and approved by the Senate.*

Article IV, Section V #10a

*The Director of Programming shall be nominated by the Selection Committee prior to the first Senate meeting in March of each year and approved by the Senate.*

Article IV, Section V #11a

*The Director of Relations shall be nominated by the Selection Committee prior to the first Senate meeting in March of each year and approved by the Senate.*

Article IV, Section V #12a

*The Director of Creativity and Advertising shall be nominated by the Selection Committee prior to the first Senate meeting in March of each year and approved by the Senate.*

Article IV, Section V #13a

*The Controller shall be nominated by the Selection Committee prior to the first Senate meeting in March of each year and approved by the Senate.*

Timeline Election Amendments

Article IV, Section VI #4

*The outgoing Hall Presidents' Council shall elect two members to serve as Co-Chairs for the following year prior to the third Friday in March of each year.*

Article IV, Section VI #9a

*The outgoing Hall Presidents' Council shall elect two members to serve as Co-Chairs for the following year prior to the third Friday in March of each year.*

Article IV, Section VII #14a

*The Club Coordinator shall be elected by a majority vote of the outgoing Club Coordinator Council prior to the first Senate meeting in March of each year.*

Article IV, Section IX #5a

*The Off-Campus Co-Presidents shall be elected by the students who reside off-campus prior to the third Friday in March of each year.*

Article VI, Section II #2

*This hearing shall be completed and allocations submitted to the Senate for approval prior to the first Senate meeting in April of each year.*

Article VI, Section III #3f

*The outgoing members of the Financial Management Board shall recommend an appropriate allocation of funds to the previous Senate the first Senate meeting in April of each year.*

Article VI, Section III #3g

*These allocations shall be approved by the previous Senate.*

Article VI, Section IV #1

*At least two Assistants to the Student Union Treasurer shall be nominated prior to the first Senate meeting in March of each year by the outgoing Student Union Treasurer and approved by the Senate.*
