**A RESOLUTION PROPOSING AN AMENDMENT TO THE
CONSTITUTION CONCERNING THE STUDENT UNION BOARD**

- I. Paragraph (1) of Subsection (a) of Section 7.1 is hereby repealed.
- II. Paragraph (1) of Subsection (a) of Section 7.1 shall now read as follows:
 - (1) The Student Union Executive Board of Directors shall be composed of the SUB Manager, the SUB Director(s) of Programming, the SUB Director of Operations, the SUB Director of Publicity, the SUB Art Director, and the SUB Director of Finance.
- III. Paragraph (4) of Subsection (c) of Section 7.1 is hereby repealed. All subsequent paragraphs in Subsection (c) shall be re-numbered accordingly.
- IV. A paragraph, to be designated Paragraph (4), shall be inserted into Section 7.1, Subsection (d), after Paragraph (3).
- V. Paragraph (4) shall read as follows:
 - (4) The Selection Committee, in accordance with Section 7.4, may determine how many directors are necessary to fulfill the position requirements.
- VI. In Paragraph (1) of Subsection (e) of Section 7.1, strike "and external" and "and press releases."
- VII. Subsection (f) of Section 7.1 is hereby repealed.
- VIII. Subsection (f) shall now read as follows:
 - (f) SUB Director of Publicity
 - (1) The Director of Publicity shall ensure that the undergraduate student body is effectively informed of all SUB programs.
 - (2) The Director of Publicity shall manage all external communication efforts for SUB.
- IX. A subsection, to be designated Subsection (g), shall be inserted into Section 7.1 after Subsection (f). All following subsections in Section 7.1 shall be re-named to follow alphabetical order.
- X. Subsection (g) shall read as follows:
 - (g) SUB Art Director
 - (1) The Art Director shall oversee and assist in all artwork associated with events, including but not limited to graphic design and photography.
 - (2) The Art Director shall work with the SUB Director of Publicity in regards to all advertising outlets.
- XI. In Paragraph (2) of Subsection (i) of Section 7.1, strike "Student Union Board Manager" and insert "SUB Director of Operations" in its place.
- XII. Paragraph (2) of Subsection (j) of Section 7.1 is hereby repealed. All subsequent paragraphs in Subsection (j) shall be re-numbered accordingly.
- XIII. Section 7.4 is hereby repealed.

XIV. Section 7.4 shall now read as follows:**(a) Selection Committee for Student Union Board Manager.**

(1) The Student Union Board Manager Selection Committee shall be composed of the incoming Student Body President, the incoming Student Body Vice-President, the outgoing SUB Manager, the outgoing Director(s) of Programming, and the Director of Student Activities. The Director of Student Activities shall cast a vote in the event of a tie.

(2) In the event the outgoing Student Union Board Manager or Director(s) of Programming are applying for Student Union Board Manager, the Student Union Board Manager or the concerned Director(s) of Programming shall not sit on the Selection Committee for his or her position. A non-returning SUB Executive Board of Directors member shall instead serve and vote during the Student Union Board Manager's selection.

(3) The Selection Committee shall nominate and present the new Student Union Board Manager by the first meeting of the Council of Representatives in March. The Council of Representatives shall review and approve this nomination.

(b) Selection Committee for SUB Director(s) of Programming, SUB Director of Operations, SUB Director of Publicity, SUB Art Director and the SUB Director of Finance.

(1) This Selection Committee shall be composed of the outgoing Student Union Board Manager, the incoming Student Union Board Manager, two outgoing Directors, the incoming Student Body President, and the Director of Student Activities. The Director of Student Activities shall cast the deciding vote in the event of a tie.

(2) The Selection Committee may determine how many Directors of Programming are necessary to fulfill the position requirements.

(3) In the event that a person up for nomination is also on the Selection Committee, that person shall not sit on the Selection Committee. Instead, a comparable non-returning SUB Executive Board of Directors member shall sit in his or her place.

(4) The Selection Committee shall nominate and present the new SUB Directors to Council of Representatives by March 15th. The Council of Representatives shall review and approve all nominations.

XV. In all places in which they appear in this Constitution in reference to the Student Union Board, strike "SUB Controller" and "Controller" and insert in lieu thereof "SUB Director of Finance" and "Director of Finance," respectively.

XVI. In all places in which they appear in this Constitution in reference to the Student Union Board, strike "SUB Director of Programming" and "Director of Programming" and insert in lieu thereof "SUB Director(s) of Programming" and "Director(s) of Programming," respectively.

XVII. This act shall take effect pursuant to Section 1.4 of the Constitution of the Undergraduate Student Body.
