

**Student Union Senate**

**Resolution SS0405-05**

**Co: Amendment to Change the Name of CPC to SUB**

**Whereas** the name Student Union Board will allow the organization to use its budget for the programming needs and wants of the student body rather than the significant cost of transitioning to the name Campus Programming Council, and

**Whereas** the student body already recognizes the name Student Union Board as the principal body responsible for campus wide events and programming, and

**Whereas** the name Student Union Board will provide familiarity and continuity during the implementation of the new institutional organization of Student Government under the recently rewritten Constitution,

**Therefore**, it be resolved that the Student Union Constitution be amended to change the name of the organization responsible for providing undergraduate students social, intellectual, and cultural events from the Campus Programming Council to the Student Union Board; to replace all instances of the name Campus Programming Council with the name Student Union Board, all instances of the abbreviation CPC with the abbreviation SUB, and all instances of the position Campus Programming Council Chairperson with the position Student Union Board Manager (*see appendix*).
