Resolution Regarding an Advisory Committee

WHEREAS the Student Activities Office is interested in gathering more proactive student input regarding the First Year Orientation program.

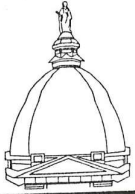
THEREFORE BE IT RESOLVED that an Advisory Committee for Enhancement of the First Year Orientation Program be formed each year to offer student input to the Student Activities Office regarding plans for the First Year Orientation program.

THEREFORE BE IT FURTHER RESOLVED that this committee consist of the following membership: the First Year Orientation Coordinator in the Student Activities Office, two representatives from the Freshman Class Council (one male one female), two senators (one male one female), two former Campus Wide Orientation Commissioners (one male one female), two former Hall Orientation Commissioners (one male one female), and one representative from the Coalition Council.

THEREFORE BE IT FURTHER RESOLVED that this group will serve as an advisory committee to the Student Activities Office and will communicate with the Student Senate to report its progress and to gauge student opinion whenever necessary.

THEREFORE BE IT FURTHER RESOLVED that the committee will select a chair and designate a meeting time at its own discretion, and the First Year Orientation Coordinator in the Student Activities Office will be consulted in setting the committee's agenda.

THEREFORE BE IT FURTHER RESOLVED that it will be the Senate's responsibility to appoint student members to this committee at the beginning of each Spring semester.


