C. [SS 2324-04: A Resolution to Fix Numerous Sidewalks Surrounding Dillon Hall](#)

1. Sam Godinez motions to move SO 2324-05 from New Business to General Orders.

2. The motion is approved.

3. Questioning

- a) Clay Chauncey: I know this issue has been brought up in the Senate before through a previous resolution. So, what is different? What has been done in the past?

- b) Sam Godinez: Last year Hunter and Derrick worked on a resolution to fix “Lake Dillon,” the sidewalk between SDH and Dillon with a massive puddle that was repaired last year. But, east of Dillon and west of Alumni there is still a massive puddle. Many students have difficulty accessing that area. It is also where they put scooters and bikes, so they can’t even get out of the dorm with these devices. Even on the south side of Dillon there is a massive puddle. If you are trying to walk from Debart or SDH, you are stopped and inconvenienced by having to get around it. I have to be specific on this resolution because I am not trying to fix “Lake Dillon.” I am trying to fix sidewalks on a different side that suffers from puddles. I only used “Lake Dillon” last meeting to show a point. Dillon hall has suffered from all of these puddles. Even

though it has been fixed on one side, I want to fix it on the other side. I want to ensure all sidewalks surrounding Dillon can be repaired.

- c) Hunter Brooke: What work has been done behind the scenes? Have you been meeting with people to make this happen?
- d) Sam Godinez: This issue was first brought to me by Connor Patrick, former CCC president, who complained about this issue. I told him I would try to get it fixed, even though I was considered elected, I had not been sworn into the senate yet. I wanted to fix it. Numerous people complained. I have met with Anthony Polotto, Director of Construction and Quality Assurance, who also happens to be my former Moreau instructor. When I first showed him a picture, he said issues would be fixed within days, but it was not fixed. It ended up being a bigger issue than what we talked about. During the next month or so with heavier rain, I noticed it didn't just affect one side, but the other too. I reached out to him again and had two or three meetings. He said the drainage around Dillon was blocked due to construction of Alumni. He said after this resolution and the Alumni construction is over, the drainage issue will be fixed.
- e) Charlie Pehl: So, once construction of Alumni is completed, the issue will resolve itself. What is the point of the resolution?

f) Sam Godinez: This is important for a couple of reasons. It brings attention to how this issue affected many people. For future construction, they can find alternatives to make sure drainage issue is not completely covered. Anthony told me they could put tubes around drainage issue. They couldn't do it here, but they could do it for others. For the whole student body, this resolution says the senate is doing something. David called me out on social media to say I'm not doing anything, and I want to defend that. Mr. Polotto said this will be a motivation to say students are being affected and will motivate things to get fixed because it is important for students.

g) Joseph Tunney: Did he read your resolution?

h) Sam Godinez: Yes. I showed him a copy. He told me I messed up the East and West directions, but that was his only correction. Other than that, he said it was completely fine.
