AN ORDER TO RAISE THE MAXIMUM LIMIT ON THE CARRY-FORWARD ACCOUNT

Whereas, according to Article XVI Section 9 (f), "The Carry-forward account shall never exceed \$100,000, notwithstanding current-year student activity fees. Any excess funds above this amount shall be placed in the Student Union Endowment. When the endowment return is negative, this provision shall be waived;"

Whereas, according to Article XVI Section 7 (f), "Net deficits from the Student Businesses shall be reconciled with funds from the Student Union Carry-forward account at the end of each fiscal year;"

Whereas, according to Article XVI Section 8 (i), "Any fiscal year-end surplus or deficit shall be applied or deducted from the balance of the Carry-forward account;"

Whereas, to the knowledge of Student Union advisors and files from past Student Union Treasurers the maximum limit on the Carry-forward account has not risen since the creation of the account;

Whereas, outside events could contribute to deficits or limited funding for the Student Union;

Whereas, in maintaining the financial health of the future Student Union it is the best practice to raise the maximum limit in the Carry-forward account to \$300,000, notwithstanding current-year activity fees;

Whereas, current returns and additions to the Student Union Endowment in the past years show that the amount of funds in the Carry-forward account would increase without affecting returns for the Student Union;

Whereas, raising the maximum amount of money in the Carry-forward account does not directly affect any allocation amount to the Student Union;

Whereas, if passed, this change would go into effect immediately, automatically raising the threshold;

Whereas, according to Article XVI Section 9 (g), "Total yearly allocations out of the Carry-forward account shall not exceed \$10,000";

Whereas, the amount of \$10,000 is 10% of the maximum of \$100,000;

Whereas, in accordance with the increase to \$300,000, the yearly total allocations out of the Carry-forward account shall be no more than \$30,000;

Whereas, the buffer of \$300,000 in the Carry-forward account would protect Student Union finances from any unforeseen circumstances; therefore, be it

Ordered, by the Student Senate of the University of Notre Dame du Lac,

That Article XVI Section 9 (f) of The Constitution of the Undergraduate Student Body is hereby changed as follows:

(f) The Carry-forward account shall never exceed \$300,000, notwithstanding current-year student activity fees. Any excess funds above this amount shall be placed in the Student Union Endowment. When the endowment return is negative, this provision shall be waived.

That Article XVI Section 9 (g) of The Constitution of the Undergraduate Student Body is hereby changed as follows:

(g) Total yearly allocations out of the Carry-forward account shall not exceed \$30,000.
