A RESOLUTION TO URGE PROTECTION OF SEXUAL ORIENTATION IN THE UNIVERSITY'S NON-DISCRIMINATION CLAUSE

Whereas, according to the 2022 Inclusive Campus Survey, 48% of LGBQ men and 35% of LGBQ women reported experiencing adverse treatment due to their sexual orientation, while 1% of straight men and 0% of straight women reported experiencing the same¹;

Whereas, a critical tenant of the student experience at Notre Dame is the ability of each individual to feel accepted and protected in the community;

Whereas, the Catechism of the Catholic Church teaches that "homosexual persons must be accepted with respect, compassion, and sensitivity," and that "every sign of unjust discrimination in their regard should be avoided²;"

Whereas, in The Spirit of Inclusion at Notre Dame, it is stated that the university "welcome[s] all people, regardless of color, gender, religion, ethnicity, sexual orientation, social or economic class, and nationality³;"

Whereas, however, according to the current policy outlined in du Lac, the university reserves the right to discriminate on the basis of sexual orientation "in the administration of any of its educational programs, admissions policies, scholarship and loan programs, athletic and other school-administered programs, or in employment" due to its omission of the aforementioned criteria⁴;

Whereas, King's College⁵ and Stonehill College⁶, other universities operated by the Congregation of Holy Cross, include the protection on the basis of sexual orientation in their non-discrimination clauses; therefore, be it

Resolved, that the Student Senate of the University of Notre Dame du Lac asks that the University strongly consider including the protection of individuals on the basis of sexual orientation in the non-discrimination clause.
